**Description** Access to internal data required for the functional performance of easier package and exemplary bladder cancer dataset with both processed RNA-seq data and information on response to ICB therapy generated by Mariathasan et al. "TGF- $\beta$  attenuates tumour response to PD-L1 blockade by contributing to exclusion of T cells", published in Nature, 2018 [doi:10.1038/nature25501](https://doi.org/10.1038/nature25501). The data is made available via [‘IMvigor210CoreBiologies’](http://research-pub.gene.com/IMvigor210CoreBiologies/) package under the CC-BY license.

`get_intercell_networks`*Get the cancer-specific intercellular networks, including a pan-cancer network*

---

**Description**

Obtain the cancer-specific intercellular networks based on literature supported pairs from the Ramilowski database (Ramilowski et al., Nat.Comm., 2015), filtering for 24 cell types acknowledged to be present in the TME. Additionally, a pan-cancer cell type is included using data from the CCLE (Barretina et al., Nature, 2012) by computing the median expression of each gene across cell lines related to the selected cancer types. A pan-cancer network is also available and this is based on the union of all ligand-receptor pairs present across the cancer-specific networks.

**Usage**

**Description**

Obtain the frequency of each ligand-receptor pair feature across the whole TCGA database. Only ligand-receptor pairs with frequency different from zero are kept. Each cell-cell pair feature score is calculated as the sum of the inverse of the frequency of all the active ligand-receptor pairs.

## Description

Obtain the cancer-specific model feature parameters learned in Lapuente-Santana et al. (2021). For each quantitative descriptor, models were trained using multi-task learning with randomized cross-validation repeated 100 times. For each quantitative descriptor, 1000 models are available (100 per task).

Obtain the cancer-specific features mean and standard deviation (sd) of the training set used in Lapuente-Santana et al. (2021) for model training by using randomized cross-validation repeated 100 times. It is required for normalization of the test set.
